Photoshop can be daunting to use, especially if you are a beginner. In the following sections, I give you a rundown of some of the basics that you need to know to get the most out of this book. Be aware that this book deals exclusively with Photoshop CS6. However, the concepts are universal, and the information applies to previous versions, and certainly to earlier versions of Photoshop and to other image-editing software as well. Mastering the workspace When you first open Photoshop, the workspace is the place where your layers reside. Photoshop keeps the original and modified layers separate and thus keeps track of the changes made to each layer. It gives you a workspace with a large, empty area to work in and a small, panel area to the right that contains the tools and menus you use most often. In the drawing area, you can manipulate objects with the various tools and tools and features. For example, you can resize an image, crop it, rotate it, and so on. In the panel on the right side, you have the main tools and icons that are usually visible at a glance. The Tools panel is at the top of the workspace, followed by the Layers palette and the Channels palette. In the next few sections, I explain these panels in more detail. The drawing area The drawing area is where you manipulate the image. You can see the drawing area highlighted in Figure 2-1. If you want to see the Tools and Layers panels at a glance, choose View⇒Workspace. The workspace opens, and the Tools panel and Layers palette are hidden (you see only the image), as shown in Figure 2-2. Work with web-ready JPEG This is a crucial trick for anyone who uses an image editor. Images should be in PNG format, because it offers many great features, including transparent backgrounds, which are very popular on the web. If you make an image with Photoshop, you should use a GIF image. Once you save the file in the PNG format or GIF format, you can open it in Photoshop Elements and resize it to web-ready dimensions. This will make your image compatible with any device. You can download an online free image resizer and use it. JPEGs should only be optimized, not shrunk. If you shrink your images for web, the quality will be drastically reduced and you will need to re-size it to match your web design. If you need to edit in RGB, don't use it If you need to edit an RGB image, use a black and white mode of your image editor. For example, you can use the CMYK mode in Photoshop. But you can simply use black and white in your photo editor and convert your image to black and white for better editing. In fact, when you use Photoshop, you don't use the RGB colour model. You may need to use a black and white image for editing. Use open file paths to speed up your workflow You often use Photoshop's "Save" function for new work. This function opens the file in a new document window. You must be aware of the following command to speed up your workflow. When you press "Ctrl+Shift+S" in Photoshop, it uses the current open file as the destination. You don't have to open a new file every time you need to save. Press Ctrl+Shift+S immediately after saving. Use the "Save for Web" function to optimize images for the web This is another very important trick. The "Save for Web" function applies compression, colour-depth reduction, and file smoothing to images. The main purpose of the "Save for Web" function is to optimize images for the web. On appeal, Theodoti claims that the trial court erroneously ordered restitution because the State was not entitled to restitution for the medical expenses incurred by the victim as a result of Theodoti's crime. The State argues that, because the victim's medical expenses were the direct result of the murder, it was entitled to restitution for the medical expenses incurred by the victim. We agree with Theodoti. In the present case, the trial court ordered restitution as part of the sentence for the Class A felony the trial court convicted him of. As noted, § 19-5-130, C.R.S.2000, authorizes a trial court to impose restitution as part of a sentence for a Class A felony. However, the General Assembly did not expressly authorize a trial court to order restitution for medical expenses incurred as a result of a crime. See § 19-5-130, C.R.S.2000; § 16-11-309.5, C.R.S.2000 (authorizing a trial court to order restitution as part of the sentence of imprisonment for a Class 1 misdemeanor). Hence, in the present case, the trial court's order for restitution was outside the statutory authority conferred by § 19-5-130, C.R.S.2000. The State argues that restitution may be ordered for the medical expenses incurred by the victim as a result of Theodoti's crime, and, therefore, its restitution award should be affirmed. We conclude that this argument is without merit. In *State v. Fain*, 8 Kan. App.2d 568, 661 P.2d 865 (1983), the defendant was charged with attempted voluntary manslaughter and criminal damage to property in addition to the charge of battery. He was convicted of all three charges. Pursuant to K.S.A. 21-3420, the trial court ordered the defendant to pay restitution to the victim for the medical expenses she incurred as a result of the defendant's crime. On appeal, the Kansas Court of Appeals found that the defendant was not liable to pay restitution for the medical expenses incurred by the victim. 8 Kan. App.2d at 567, 661 P.2d at 866. The court reasoned that restitution should not be awarded for expenses incurred as a direct result of the defendant's own criminal acts. 8 Kan.App.2d at 569, 661 P.2d at 867. The
